My rights:

I can request information about the data stored about myself at dataprivacy@daimlertruck.com. Under certain conditions, I can also request the rectification or erasure of my data. I may also be entitled to a right to restrict the processing of my personal data as well as a right to have the personal data provided by me disclosed in a structured, commonly used and machine-readable format.

I have the right to lodge a complaint with the data privacy officer or a data protection supervisory authority if I feel that the processing of my personal information violates the GDPR or other laws (Art. 77 of the GDPR).
